Century Synthetic Fiber Corporation hereby provides an explanation for the fluctuation in after-tax profit for Quarter I of 2025 compared to Quarter I of 2024, as presented in the VAS financial statements prepared by the Company on April 24, 2025, as follows:

Reasons:

The Parent Company's and the Consolidated net revenue increased by VND 112 billion and VND 110 billion, respectively - equivalent to increases of 42% and 41.6% year-on-year - mainly due to higher sales volume. The Parent Company's gross profit rose by VND 50.77 billion and the Consolidated gross profit increased by VND 45.9 billion, corresponding to increases of 157% and 142% year-on-year, driven by both higher sales volume and higher selling prices.

The Parent Company's profit before tax increased by VND 65.15 billion, equivalent to a 6,953% rise compared to the same period last year; profit after tax increased by VND 52.5 billion, or 10,443%, primarily due to the significant increase in gross profit, partially supported by gains in financial income from exchange rate differences and reduced selling expenses.







The Consolidated profit before tax increased by VND 47.55 billion, equivalent to a 4,150% rise year-on-year; profit after tax increased by VND 34.9 billion, equivalent to a 4,905% increase, mainly attributable to the growth in gross profit.
